- Clear wrap-around eye protection, ear protection, weapons cleaning kit. (Will be provided)
- Trainees will be provided with tactical clothing consisting of boots, t-shirt, BDUs, baseball hat and belt. (Will be provided)

Admission:

Courses are typically open to all sworn police personnel, armed licensed security officers, active military along with certified range instructors, S.W.A.T and all superior police personnel. In the case of this outing we will be requiring the **applicant trainee's full name, date of birth and social security number to conduct a nationwide background check.** Trainees attending the course must bring valid picture identification. **The minimum for hosting a tactical day is 8 attendees and the maximum is 50 attendees. Courses may be one or two days and typically are comprised of an 8 hour day.**

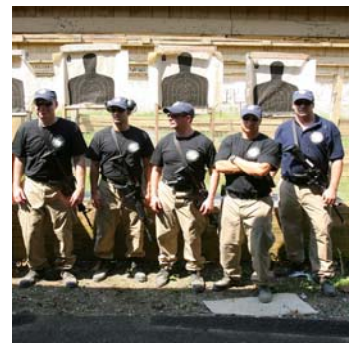
Methodology:
